Demonstrates safe and effective technique for changing the tapes	<ul> <li>2 nurses present, 1 to hold tube and 1 to apply new tapes</li> <li>Nurse performing the dressing leads the team</li> <li>Adjusts the tapes ensuring that 1 finger slides underneath the tube</li> <li>Ensures that the tube is central and secure.</li> <li>Ensures that the patient is comfortable at the end of the procedure</li> <li>Documents and updates the patients management plan</li> </ul>

Discuss the <i>specific</i> infection control measures related to this procedure	<ul> <li>Face masks and eye protection must be worn where there is a risk of blood, body fluids, secretions or excretions splashing into the face and eyes i.e. during suctioning, dressing and tape change</li> <li>Discard brush after each use</li> <li>Disposes of brush in yellow bag</li> <li>Disposes of the water down the sluice or toilet if in sideward</li> <li>Rinses and dries the jug</li> <li>Change jug every 24 hours and label</li> </ul>
